ACADEMIC ACHIEVEMENTS

Trinity Christian School continues its efforts to provide a premier education to its students. Our curriculum is continually reviewed to insure the preparation of our students for their next steps in life after their Trinity experience.

Our students are administered numerous standardized tests to monitor their progress. Students in 1st through 8th grades take the Iowa Assessments Exam (IA).

Students are required to take the PSAT in preparation for the SAT.

Trinity students' test scores have enabled them to pursue their post-secondary degrees at the colleges and universities of their choice, with many being accepted during the early admissions process.

Iowa Assessments Exam (IA)

Trinity Christian School annually administers the IA to EVERY student in 1st through the 8th grades. Our students continue to out-perform the majority of students who are administered this test throughout the United States.

National Beta Club

Recently the National Beta Club announced Trinity Christian School as a School of Distinction. This award speaks to Trinity's commitment to academic excellence and illustrates dedication to preparing students for college and career readiness. National Beta is committed to recognizing and promoting high academic achievement, rewarding and nurturing worthy character, improving student leadership skills, and encouraging service to others. National Beta understands the importance of these qualities and strives to instill these beliefs through their motto, "Let Us Lead by Serving Others".

Exchange Club and Rotary Club Speech Contest

Each year, our high school students are eligible to participate in the Exchange Club Speech contest and the Rotary Club Speech Contest. For each contest, students submit and present their speeches to a committee of faculty who select one student to represent our school. This year, our Rotary Club Speech participant was Miss Laney Ray, and our Exchange Club Speech participant was Miss Emma Sumner. At this year's Rotary Club Luncheon, Laney was awarded first place, and at the Exchange Club luncheon, Emma placed second runner-up.

The University of Georgia Certificate of Merit

2022-23 Teachers of the Year

The Georgia Independent School Association conducts the Annual Teachers of the Year Program each school year. This is an opportunity for Trinity Christian School to recognize and celebrate the hard work and dedication of our outstanding teachers. Our Annual Teachers of the Year for 2022-23 are Mrs. Nona Dasher (Elementary), Mrs. Allison Rogers (Middle School), and Mrs. Amanda Herrington (High School).



National Merit Scholar

Each year, our 10th and 11th grade students take the PSAT in the fall and are amongst 1.5 million students who enter in the National Merit Scholarship Program. Of all of these students, 50,000 students are named National Merit Scholars. Mr. Thomas McMichael is exceptionally bright, scored in the top 3% in the nation, and has officially been named a National Merit Scholar. In September, 16,000 of those students will move on to be Semi-Finalists and then Finalists who will compete for close to 8,000 merit scholarships given in 2024.

The Christian Character Award

This award is presented to students selected by their teachers who represent good citizenship and Christian Character in the classroom. D.A.R. Good Citizen

For over half a century, the Daughters of the American Revolution Good Citizens Committee has rendered a valuable service to the youth of our nation by recognizing and regarding the qualities of dependability, service, leadership, and patriotism in our high school seniors. Each year, one of our seniors is selected to participate in an Americanism essay contest where they are given two hours to write on an impromptu topic that will be submitted to the D.A.R. committee for evaluation. Miss Janelle Blackstock was selected as this year's D.A.R. Good Citizen.

ACE Award

The Exchange Club of Dublin honors four students from each of the local high schools who have overcome obstacles and difficult circumstances in their life that have impacted their educational journey. They recognize these students by giving them the ACE Award, which stands for "Accepting the Challenge of Excellence. The 2022-23 ACE Award Winner for Trinity was Miss Kaitlin Dekowski.

The minimum qualifications for this distinction are as follows: 3.7 HOPE GPA combined with a minimum of 1200 in Math and Reading on the SAT or a composite score of 26 on the ACT in a one-time sitting, or Valedictorian or Salutatorian.

FINANCIAL ANALYSIS

FISCAL MANAGEMENT

Trinity Christian School continues to operate within the framework of sound fiscal management principles. The fiscal year is June 1 – May 31. A preliminary budget is prepared under the direction of the Head of School in conjunction with the Board Treasurer and is approved by the Board of Directors. The financial office is overseen by the Head of School, Business Manager, and Finance Office Assistant. The budget is comprised of 10 categories with over 75 various cost centers and in excess of 300 detail line items to specifically track and record all income and expenses. Following each fiscal year, our financial records are submitted for review to the accounting firm of Symphona CPAs & Advisors. A copy of this report is provided to our Board of Directors. Additionally, accreditation standards require the school to be fully audited, at minimum, every five years. The last audit was completed during the 2021-22 fiscal year by the accounting firm of Symphona CPAs & Advisors in Dublin, GA.

Financial Aid

Continued good enrollment numbers at Trinity are attributed to several factors, one of which is a balanced Financial Aid program approved by our Board of Directors. This program has three specific areas: GOAL Scholarship, Tuition Assistance, Pastor Partnership. It is designed to help bridge the gap for families who demonstrate financial need and desire the environment our school provides.

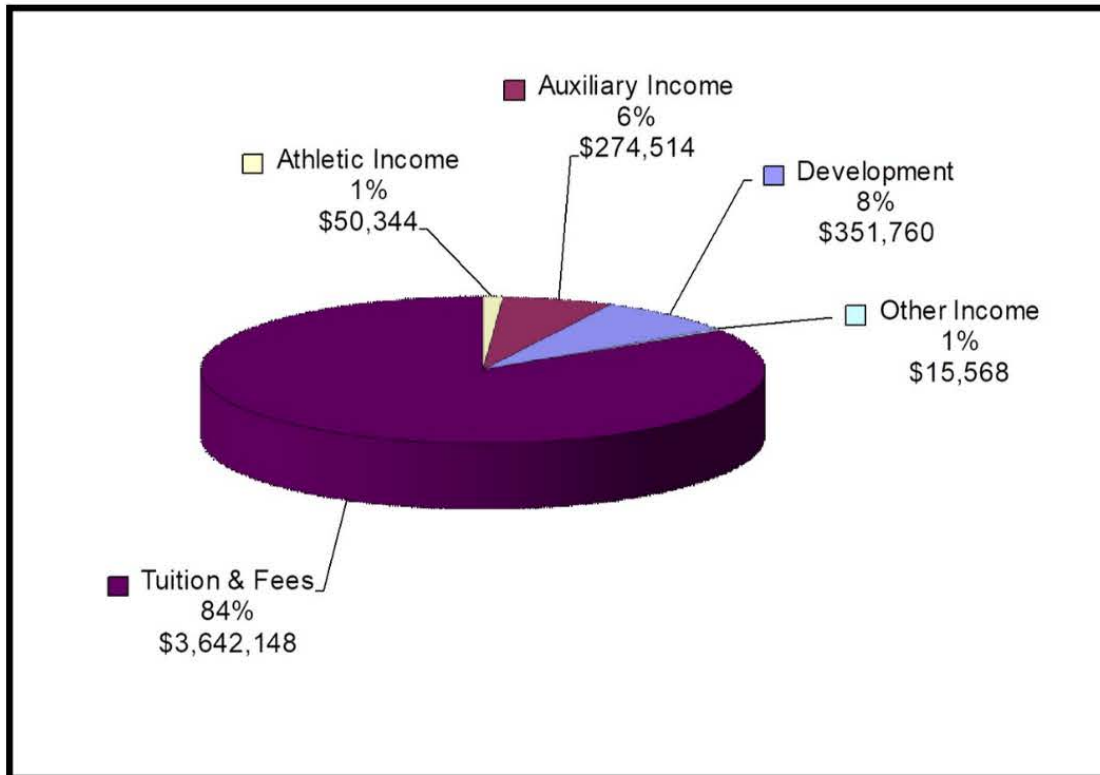
- 218 students from 134 families received Financial Aid through these programs during the 2022-23 year.
- The Financial Aid provided to families through these programs included the following:
 - * GOAL Scholarship \$555,319 (at no cost to Trinity as these Scholarships were funded by redirected tax dollars contributed to GOAL)
 - * Tuition Assistance \$73,394
 - * Pastor's Partnership \$56,694
- The revenue generated from 2022-23 Financial Aid was a total of \$1,517,848 (\$962,529 from families and \$555,319 from GOAL).



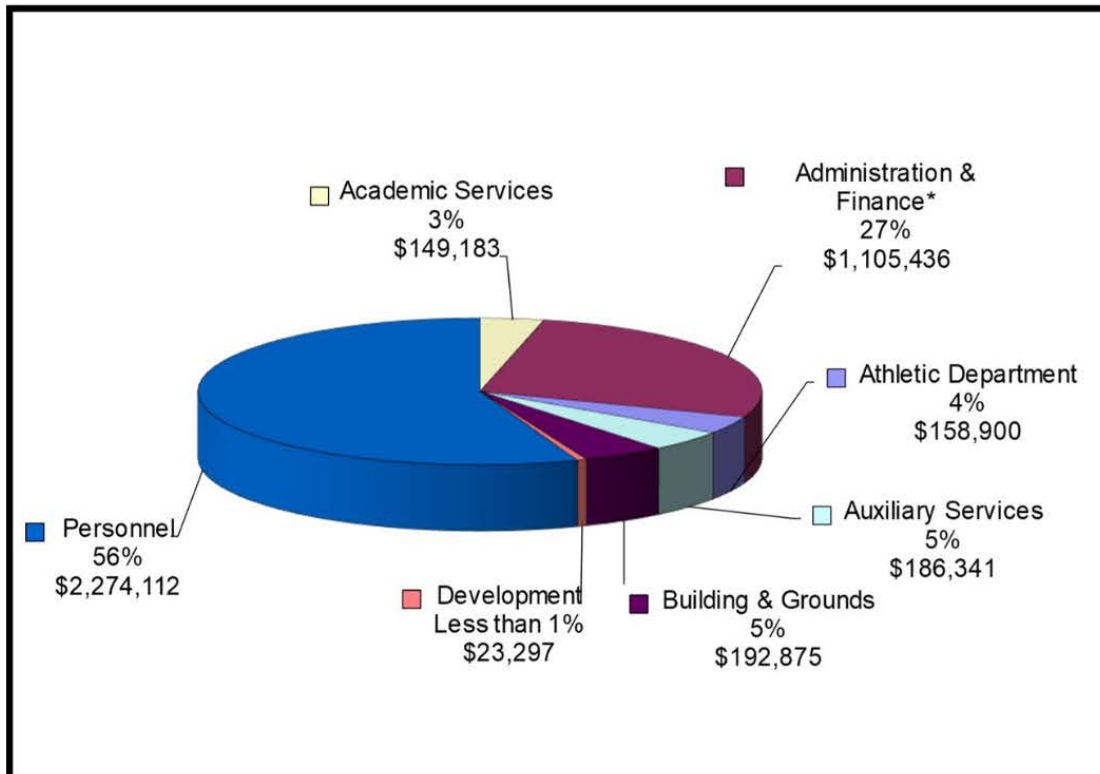
