Welcome to the Trinity Christian School Family! We are excited to have your family join us for the 2026-27 school year. Thank you for your interest in our Financial Aid Programs. Our current Financial Aid programs include:

- Georgia GOAL Scholarship- (available to current recipients and *eligible, new* K4-12th grade students and based on need of family & availability of funds)
- Tuition Assistance (based on need of family, need of school, and availability of funds)
- Pastor's Partnership (available to full-time ministerial staff)
- Alumni Discount- (available to K4-12th grade students whose parent is a TCS alumni)

According to our policy, **Applicants must have paid the Application Fee prior to being considered for Financial Aid. Financial Aid awards are contingent upon notification of your acceptance from the Admissions office. Also, Financial Aid applies only to tuition and not to fees, such as application and registration. Assistance is not automatically renewed from one year to the next. Please be aware that allocations are determined by a number of factors, including funds available. If you reapply in the future, please understand awards are not necessarily the same as in previous years.**

Trinity Christian School is a Georgia Promise Scholarship Participating Private School. The Georgia Promise Scholarship is administered by the Georgia Education Savings Authority (GESA). Please understand that Georgia GOAL Scholarship and Georgia Promise Scholarship CANNOT STACK. Therefore, a student who receives funding from the Georgia Promise Scholarship will be INELIGIBLE to receive Georgia GOAL Scholarship funds.

When applying for any Financial Aid component at Trinity Christian School, new applicants (and returning K4 students) must indicate if they have applied to the Georgia Promise Scholarship Program. If so, Trinity Christian School requires evidence of the approved amount or denial BEFORE processing the Trinity Christian School Financial Aid application. The amount awarded by Georgia Promise Scholarship will be taken into consideration on the Financial Aid application, but will **not** be included in the balance due to Trinity Christian School on the Financial Aid award letter.

If you wish to be considered for assistance for the 2026-27 school year, please complete the attached Financial Aid Application and return it promptly with the required documents. **Applications will not be processed until ALL the required documents are received.** Financial Aid Applications may be returned via email to [kmgrooms@trinitydublin.org](mailto:kmgrooms@trinitydublin.org) or you may bring **the completed application with the required documents** to the school office. Financial Aid applications will be printed upon request.

Applications received (**with all required documents**) by **February 28<sup>th</sup>** will be given first consideration, allowing us to prioritize allocation of available funds. We will begin to process applications March 2, 2026. **Please understand awards can only be given as funds are available.** Applications and documents received after April 17, 2026 may not be processed until June 1, 2026.
